Meeting Minutes February 21, 2023 Via Zoom

1. **Tree Legislation**. BJ discussed the sample tree legislation from three communities that were circulated. Members should review the legislation and ascertain what components should be included in the OB legislation.

Action: All members to review and provide comments to BJ by Feb 28, 2023. BJ to prepare a summary of comments.

2. Beach Management. JW discussed Dune Fence Day which takes place the second week of May. The installation is very physical, lots of manual labor with heavy rolls of dune fence that need to be moved. The lifeguards work with the Village employees to install dune fencing. Discussion of the role of VOBEC. Both VOBEC and Lifeguards included cost of dune fencing in their respective budgets.

Action: CG to communicate with the Village to clarify where dune fencing appears in the budget.
